




The Coordinator of RLJ Health Science Incubator shall be the primary contact person for all transactions with the incubator.

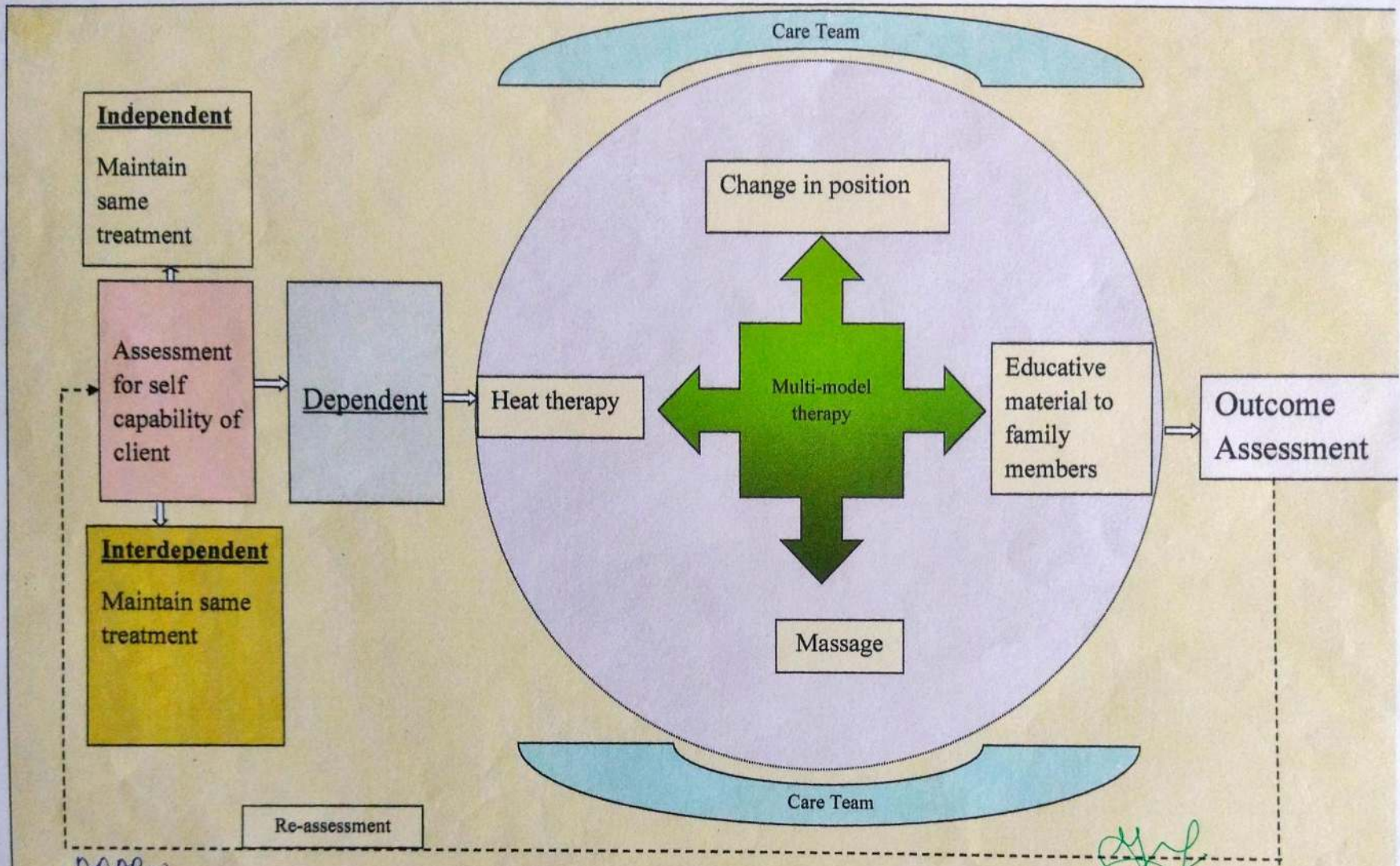
