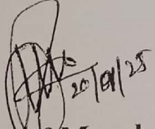


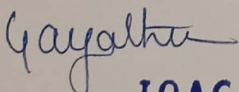
Parents feedback analysis on curriculum



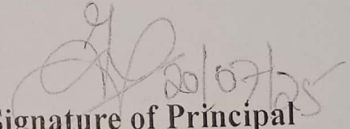
Overall feedback analysis of parents on curriculum

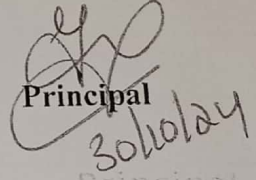

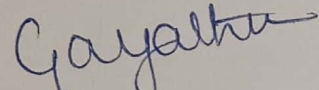

through PTA group. Extra revision classes for pathology are planned and it's going on. The committee members requested parents to fill PTA feedback on overall opinion of institution & curriculum.

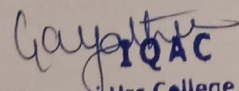
3. Any other matter: the points discussed in any other issues are as follows:-

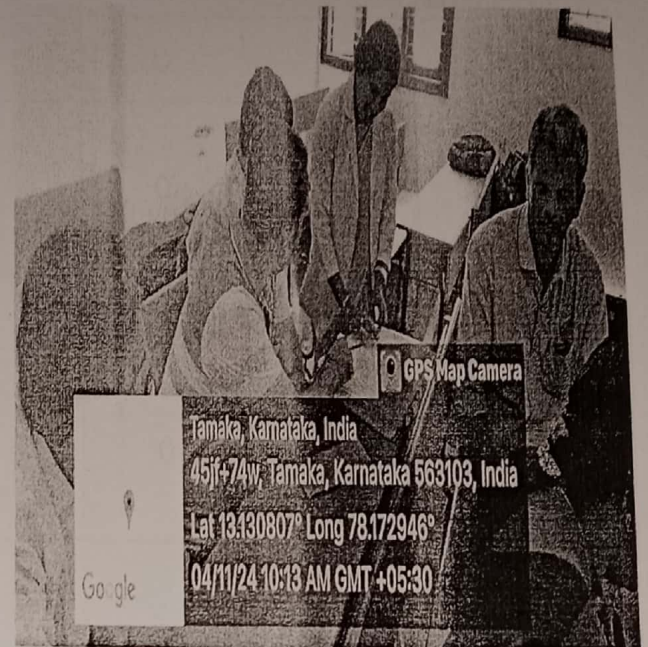

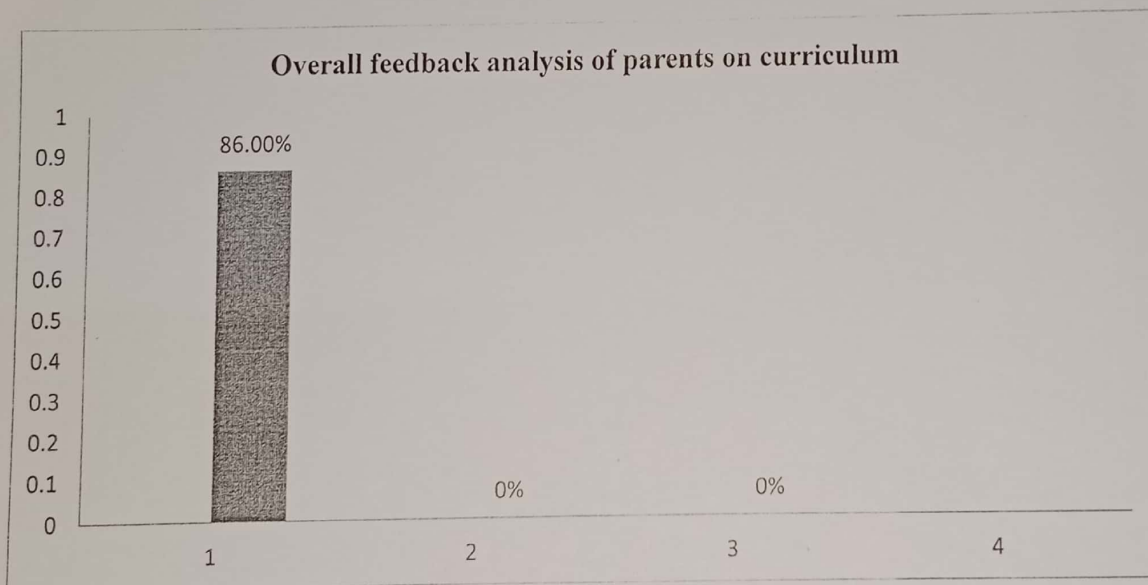
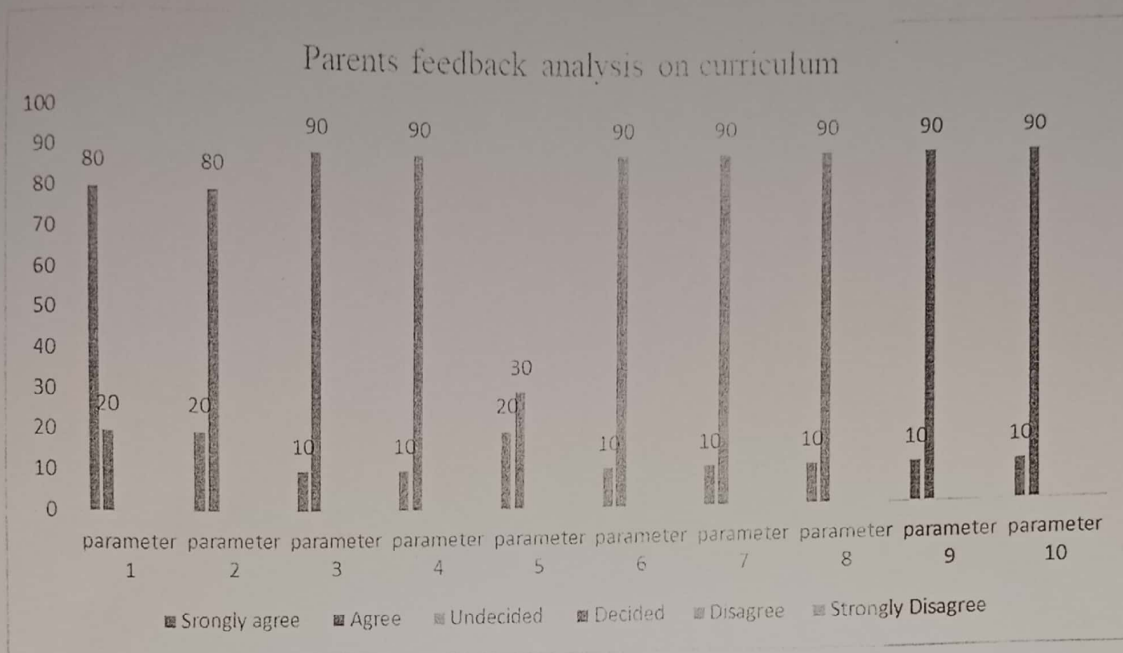
