OPTIMAL FUND MANAGEMENT BY SRI DEVARAJ URS COLLEGE OF NURSING

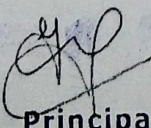

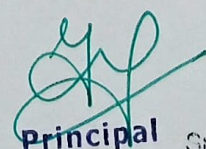
All collection of the college get credited to the Bank account which is maintained is ICICI Bank. All fees and other payable fees are directly credited to this account through e-mode.

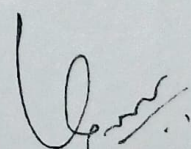
The college accounts are computerised with **Logisys Software**, accounts are maintained using **Tally Software** and periodic reports are submitted to the Academy for appraisal.

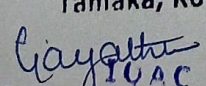
Every Year College prepare a Budget and presents before the Executive Council. After discussion, the approved budget will be utilised by the College.

Annual Financial Budget Plan of Action

Before the commencement of every Academic year, the inputs are collected from HOD's, Course Coordinators, Class Coordinators, Librarians and Hostel Warden, the Principal (SDUCON) for the preparation of Annual Budget including planned Revenue Expenditure and Capital Expenditure and the proposed Annual Fee Structure.

Based on their inputs, a draft Budget Plan is prepared and discussed with Chief Financial Officer (SDUAHER) who will place it on the Finance Committee for approval. After the Draft Budget Plan and proposed Annual Fee Structure are passed by Finance Committee, it will be placed for approval in the SDUAHER Executive Meeting.

Once this gets passed through the Executive Council, the Finalized Fee Structure will be uploaded in the website, displayed in notice board and announced to the Students/Parents.
